TRIP COST INCLUSIONS

- 250GB/7nights high-speed low-latency internet at sea with maritime Starlink. (Extra internet used, above 250GB a week, will be charged at cost.)
- All meals, snacks, bottled water & refreshments
- Alcoholic beverages (local beers and 4 bottles of local wine per night each boat)
- Beach activities
- Entrance fees and permits at our seasonal home ports;
- Transfers to/ from shore to the ship (Airport Transfer);
- Domestic concierge fees
- Services of an English-speaking expedition leader;
- Service of the Crew;
- Personal laundry;
- Unlimited massage with our spa therapist;
- Diving for the certified divers;
- Use of all water sports equipment including dive equipment, wetsuits, fins and masks for certified divers, snorkel equipment, sea kayaks, water skis, wakeboards, SUP boards, donut, and fishing gear.
- A total of 50 nautical miles per charter day (50 NM) is included in the price of the cruise itinerary.
- Without additional cost, nautical miles can be accumulated as long as they don't exceed the total of 50 NM multiplied by the number of charter days. A surcharge may be applied for extra nautical miles.

TRAVEL INSURANCE

Silolona Sojourns strongly recommends its guests purchase trip cancellation/interruption insurance to protect the travel investment at the time of contract signature. This coverage will offset cancellation charges in the event of illness before or during the trip. Such trip cancellation/interruption as well as baggage insurance are available at travel agencies.

The purchase of Medical Insurance including medical expenses, evacuation, and 24-hour consultation assistance coverage, is also strongly suggested.

BOOKING PROCEDURES

- A request for booking cruises on Silolona & Si Datu Bua can be made via email, website contact form, or telephone.
- To secure a booking on Silolona and/or & Si Datu Bua, Silolona Sojourns requires a non-refundable deposit, which shall be transferred upon trip-date confirmation. Only bookings secured by deposit payment will be honored.

PAYMENT

Due to regulations of the Indonesian Government, Silolona Sojourns is only allowed to transact charges in Indonesian Rupiah. These transactions will be done based on the prevailing exchange rates on the day of the actual transaction. Payments to Silolona Sojourns can be made by bank transfer to our USD bank account or by credit card via payment link. Any bank fees, or credit card surcharges will be borne by the client. Our bank details are listed on each invoice, should you wish to pay by credit card, please request a payment link to be added to the invoice.

Payments should be made according to the following schedule:

Charter confirmation one year or more in advance (>365 days)

Deposit	30%
Payment 2 - due 6 months before the trip	40%
Final Payment - due 90 days before the trip	30%

Charter confirmation less 1 year to 6 months prior to trip (364 days – 180 days)

Deposit	30%
Payment 2 - due 6 months before the trip	40%
Final Payment - due 90 days before the trip	30%

Charter confirmation 6 months to 3 months prior to trip (179 days – 90 days)

Deposit	40%
Final Payment - due 90 days before the trip	60%

BOOKING RESCHEDULING

Should the client not be able to make the trip dates due to whatever reason, the following rescheduling schedule shall be applied:

Time of reschedule	Fee	Allowed to reschedule:
One year or more prior to the trip	No fee	Up to 3 times, price will be adjusted each time according to updated rates. After which, it will be considered a cancellation.
One year-6 months prior to the trip	10% of full charter price	Up to 3 times, price will be adjusted each time according to updated rates. After which, it will be considered a cancellation.
6 months-3 months prior to the trip	20% of full charter price	Up to 2 times, price will be adjusted each time according to updated rates. After which, it will be considered a cancellation.
3 months - 2 months prior to the trip	30% of full charter price	Up to 2 times, price will be adjusted each time according to updated rates. After which, it will be considered a cancellation.
61-30 days prior to the trip	40% of full charter price	1 time only, price will be adjusted each time according to updated rates. After which it will be considered a cancellation.
<29-0 days prior to the trip	50% of full charter price	1 time only, price will be adjusted each time according to updated rates. After which it will be considered a cancellation.

New dates for the rescheduled trip are subject to availability.

BOOKING CANCELLATION

- In the event of trip cancellation, Silolona Sojourns is not responsible for additional expenses incurred by trip members.
- Silolona Sojourns is not responsible for either charges or cancellation of trips by the passengers overlooking to verify the validity of their passport (over 6 months of validity is required to enter Indonesia) and visa entry requirements for citizens of certain countries which are required to apply for the Indonesian Tourist Visa abroad.

Cancellation fees are based on the following schedule:

BESPOKE JOURNEYS

Our bespoke journeys are tailored by our team of regional specialists to match the exacting specifications and interests of our clients, from a family dive certification trip, to a cultural land excursion, to a conservation specialist trip, to bird watching in the outer islands.

These bespoke journeys are often challenging to organise, especially in remote areas, and may involve a chartered or private plane, a private speed boat, a helicopter, or travel with a specialist guide.

Such excursions and extra services cost outside of our trip inclusions listed above will be charged in the final invoice if made more than 90 days in advance, or in a separate invoice prior to the trip departure. Payment for these excursions and extra services is required prior to the trip departure and is non-refundable should the client cancel or reschedule the trip.

PROOF OF INSURANCE

Silolona Sojourns will send, upon request, proof of personal liability for up to USD 5,000,000.

PARTICIPANT RESPONSIBILITY

Trip members assume the responsibility to select/design a trip most appropriate to their physical abilities and interests. Members are responsible for being in sufficiently good health to undertake their trip and may be required to obtain a physician's release to participate in the trip.

Members are also responsible for studying all pre-departure information, bringing all detailed equipment and clothing, conforming to standards of personal hygiene to minimize the risk of traveler's disease as set up by the trip leader, and acting in a manner considerate of fellow group members and the countries visited.

Smoking is not permitted in buses, cars, below decks on our boats, tented camps, and other designated non-smoking areas.

AIRLINE RESPONSIBILITY

The airlines concerned are not to be held responsible for any act, omission, or event, during the time the passenger is not on board their planes or conveyances. The passenger contract in use by the airline concerned, when issued, shall constitute the sole contract between the airline and the purchaser of their programs and/or passengers. Similar responsibility as noted above applies to all types of carriers.

LIMITATION OF LIABILITY

Silolona Sojourns, its owners, agents, employees, and affiliated companies, hereby give notice that they act only as agents for hotels, transportation companies, land operators, and suppliers of travel services, and assume no responsibility or liability whatsoever in connection with the operation or service of any aircraft, motor vehicle or boat, other conveyance, inn, lodge, or hotel which may be used wholly or in part, for services to Silolona Sojourns trip members.

Silolona Sojourns, its operators, airlines, and agents will not be responsible for any act, error, or omission, nor for any injury, loss, accident, delay, inconvenience, irregularity, or damage which may be occasioned by any cause whatsoever, including acts of nature, civil disturbance, government restrictions, or failure of any means of conveyance to adhere to published schedules.

Silolona Sojourns reserves the right prior to departure, and after departure, to re-price, cancel, or withdraw any tour, trip, or expedition for any reason whatsoever, and to alter or omit any part of the itinerary,

to substitute hotels or leaders, or to change any means of conveyance without notice and without allowance of refund with the liability for increased costs, in any, borne by the trip members.

If tours, treks, or expeditions are canceled due to acts of insurrection, strikes, acts of God, or any cause beyond the control of Silolona Sojourns; refunds will be based on the difference between the original trip price and the cost of services already provided. Silolona Sojourns reserves the right to accept or reject one as a trip member at any time.

The company is not responsible for: weather, sea, or road conditions affecting the cruise and causing delays or re-routing, sickness, government action, flight delays, and changes due to force majeure.

RISK AND RELEASE OF LIABILITY

Silolona Sojourns contracts with a network of business firms, governmental agencies, and individuals for field services. These businesses, firms, governmental agencies, and persons may include United States or foreign-based companies, subcontractors, business concerns, agents, employees, and associates (all of whom shall be referred to as "third parties"). In many instances, Silolona Sojourns is required to contract with particular third parties solely at the insistence of a foreign government or its agencies. To the best of Silolona Sojourns' knowledge, such third parties are qualified to perform the tasks for which they have been retained. Silolona Sojourns cannot fully supervise or guarantee the performance of such third parties because of, among other things, remote geographic locations, lack of Telecommunication facilities, time constraints, and governmental restrictions.

Therefore, contract signatories knowingly assume this risk and fully release and hold harmless Silolona Sojourns from any and all liabilities for all of the acts and omissions of all such third parties unless PT Silolona Sojourns has been shown to be reckless in its dealings with or reliance upon such third parties. The Complete Assumption of Risk of Travel and Release of Silolona Sojourns Liability shall be legally binding upon the signatory company's clients, all minors under the age of 21 traveling, their heirs, successors, assigns, and legal representatives; it being by intention to fully assume all the risk of travel and to release Silolona Sojourns from any and all liabilities to the maximum extent permitted by law. It is further agreed that Silolona Sojourns will be fully indemnified for all its costs, expenses, damages, etc. (including attorneys' fees), arising from or attributable to any claims or actions arising from guests' travel with Silolona Sojourns and which claims or actions are specifically released by the contract signatory company's clients by agreeing to these conditions and signing the contract liability release form and deliver to Silolona Sojourns.

The cost of all Silolona Sojourns trips has been based upon trip participants executing this Complete Assumption of Risk of Travel and Release of Silolona Sojourns Liability. The signatory's company has voluntarily agreed to sell and have guests participate in a PT Silolona Sojourns trip and willingly execute this document. It is understood that its contents and legal ramifications, especially those pertaining to the signatory company's full assumption of the risk of travel and the agreement to these conditions release Silolona Sojourns from any and all liability to the maximum extent permitted by law.

It is agreed that in the unlikely event that a dispute of any kind arises between the signatory's company and Silolona Sojourns, the following conditions will apply, the maximum amount of recovery to which the company will be entitled under any and all circumstances will be the sum of the trip and air cost of the booked trip with Silolona Sojourns.

It is agreed that in the event any part or portion of this trip member's agreement regarding Complete Assumption of Risk of Travel and Release of Silolona Sojourns is found to be void or unenforceable, then such part or portion will be stricken but the rest of the agreement will be given full force and effect. Booking conditions are agreed upon by signature of an official Silolona Sojourns charter agreement.

SPECIAL CONDITIONS / ADDENDUM

Should a CDC Travel Health Notice of level 3 or higher for any country to or from the charter destination be issued, or flights be canceled due to health alerts, a rescheduling of charter dates shall be agreed. The Rescheduling Addendum must be signed within 14 days of the notification of intent to reschedule and new allowable dates must be within one year of the initial charter date. Should the vessel be sold or disabled after the reschedule is in effect, the original Charter Agreement will be considered null, and all funds will be returned by all parties.
